**“Let’s Grow”**

**CONTEST RULES AND REGULATIONS**

**1. HOW TO PARTICIPATE**

The sponsor of the Let's Grow (“the Contest”) is Saskatchewan Pension Plan (SPP).

**1.1 Eligibility:**

The Contest is open to all residents of Canada who have reached the age of majority in their Province of residence, except employees of SPP and Dutch Growers of Saskatoon, Saskatchewan and its affiliates, franchisees, agents, associates, dealers, representatives, advertising and promotional agencies and members of the immediate family of these employees or any person with whom they are domiciled (“Contestants”).

**1.2 Contest Period:**

The contest period - **on 00:00, (CST), March 21, 2013 to 23:59, (CST), May 21, 2013**; Contestants may participate in the contest by joining SPP or referring someone to SPP during the contest period through the web-based or paper forms.

**1.3 Contest Entry:**

Contestants who complete the “Apply Online” form during the contest period will be automatically entered to win. Individuals who refer someone to the Plan through the web-based form at saskpension.com will be automatically entered to win. Contestants who provide a paper member application instead of applying online will be automatically entered to win as will contestants who initiate a transfer in of RRSP or RPP funds.

**1.4 Awarding of Prize:**

In order to be eligible to receive the Prize, the person whose name is drawn must provide the required contact information (name, telephone number or email address, address) at time of completion of the online form or on the mail in member application form and have complied with these Rules.

## **2. PRIZE**

### **2.1 Prize:**

There will be one (1) prize awarded for the contest period

**Contest period: 00:00, (CST), March 21, 2013 to 23:59, (CST), May 21, 2013**

The prize consists of one gift certificate valued at \$500 from Dutch Growers in Saskatoon, Saskatchewan.

There will be a random draw for the Contest Period (See section 2.3). The Prize will be forwarded to the winner within four (4) to six (6) weeks from the date when the winner's signed Declaration and Release Form is received by SPP.

### **2.2 Odds:**

The odds of being randomly selected to win a Prize depend on the total number of eligible entries received during each applicable Contest Period.

### **2.3 Prize Draw:**

One prize will be awarded by random computer generated draw from all eligible Contest entries received during the applicable Contest Period. Draw to be held at the SPP Head Office on May 23, 2013.

### **2.4 Notification of Selection:**

The selected Contestants will be contacted by phone, mail or email (using the contact information provided by Contestant at time of entering the Contest) at least three (3) times within the fourteen (14) days after the Draw.

If the selected Contestant cannot be contacted in that time, another Contestant will be randomly selected and the initial selected Contestant will be disqualified and will have no recourse against SPP or anyone involved in the Contest.

The selected entrant will have seven (7) days from the date of receipt to provide confirmation satisfactory to SPP or its representative that the entrant has read and understood all of these terms and conditions. If the selected entrant does not do so within this period of time, another Contestant will be randomly selected and the initial selected entrant will be disqualified and will have no recourse towards SPP or anyone involved in the Contest.

### **3. GENERAL RULES**

**3.1** The Prize claim is subject to verification by SPP and/or its designated representatives. Entries made with multiple addresses, under multiple identities, or through the use of any device or artifice to enter multiple times or entries that are in excess of the permitted number of entries during the Contest period are automatically void.

All Contest entries obtained through unauthorized sources or which are incomplete, illegible, mutilated, altered, reproduced, forged, irregular or fraudulent in any way or otherwise not in compliance with these Rules are automatically void. SPP will be the sole and final reference source in validating a Prize claim.

**3.2** By participating, each Contestant and selected winner agrees: (a) to be bound by these Rules and the decisions of SPP, (b) to release and hold harmless SPP, its affiliates, subsidiaries, and independent contractors, and their respective directors, officers, employees, agents and representatives including advertising and promotion agencies, from any and all liability for claims/damages including, but not limited to, claims/damages for personal injury, for property damage with respect to acceptance, possession or use or misuse of the Prize or participation in the Contest; (c) to allow SPP or use or provide to Dutch Growers of Saskatoon, Saskatchewan his/her name, address, city, province, of residence, photograph, video, or any likeness for advertising or publicity purposes without any additional compensation or additional written release.

**3.3** The decisions of SPP in relation to this Contest will be final and binding on all entrants.

**3.4** SPP shall not be responsible for incorrect or inaccurate transcription or registration of Contest entry information, technical malfunctions, lost/delayed data transmission, omission, interruption, deletion, defect, faulty, incomplete, incomprehensible, or erased computer or network transmissions, line failures of any telephone network, failure of computer equipment, software, inability to access any online service or web site, inability to submit the online survey, or any other error or malfunction, or any injury or damage to entrant's or any other person's computer related to or resulting from participation or downloading any materials in this Contest, or for late, lost, stolen, postage due, illegible or misdirected entries.

**3.5** SPP will not be responsible for lost, stolen, illegible or destroyed contest entries.

**3.6** SPP reserves the right to cancel, terminate, or suspend this Contest, at its sole discretion, in the event of a technical failure, computer virus or bug, unauthorized human intervention, fraud or any other occurrence or cause beyond its control that corrupts or adversely affects the administration, security, fairness or normal operation of the Contest.

**3.7** If a selected entrant is awarded the Prize due to a system error, malfunction or defect the Prize will be returned to the Prize pool, to be re-awarded.

**3.8** Under no circumstances will SPP, its affiliates, subsidiaries, and independent contractors, and their respective directors, officers, employees, and agents, including advertising and promotion agencies be required to award more Prizes than what is indicated in these Rules or award the Prizes other than in accordance with these Rules.

**3.9** The Contest is subject to all Federal, Provincial and local laws, as well as the rules adopted in view of said laws. The personal information provided to enter the Contest will be used only to administer the Contest, and for no other reason unless the participant has consented to receiving further communication for the SPP.
