Introducing ERS

Greetings Business Owners,

Saskatchewan Pension Plan (SPP) recently contacted you regarding implementation of the Employer Remittance System (ERS). Thank you for your co-operation and willingness to begin managing your SPP business plan in this portal.

We want to take a moment to review how ERS affects you and your business. Please take a few moments to look through the questions and answers. If you want further information, feel free to contact our Client Service team for assistance.

How will I obtain my employer remittance form for making contributions?

Each month the administrator of your business plan will receive a courtesy email reminder to make contributions. After the contributions are remitted in ERS and posted by SPP, you will be able to access your 'Employer Remittance Statement' in the Documents tab. This will report the amount of the most recent contribution and the year-to-date contribution total.

Why was ERS implemented?

This secure portal was created to provide a self-service opportunity for you to manage your SPP account any time of the day or night. You are able to add and remove employees from your plan, set up payment methods, make contributions and retrieve remittance statements for your records.

Do I need to mail, email or fax my Employer Remittance Statement to SPP?

You now complete the remittance step in ERS and DO NOT need to mail or email a remittance form to SPP.

HOW CAN I CONTACT SPP?

ERS has a secure message option. We encourage you to use this system for contacting SPP. It makes it so easy to track your interaction with us.
